#### 5. Membership Terms and Conditions

All members of Sundowners Yacht Club are deemed to accept the Club Constitution, Bylaws & Rules and Event Terms & Conditions. These are available at sundowners.org.uk or from any club officer.

We do like to meet new members face-to-face if at all possible, this is easily done through attending one of the regular club evenings or we can arrange a Zoom meeting. The Club Bylaws require your application to be approved by the management committee. The Committee meets regularly and you will be notified in writing by the Membership Secretary when your membership has been approved.

We ask that all applications are accompanied by a digital, passport-style photo to help with administration and organising club activities. This should be emailed in JPEG format to the Membership Secretary.

Membership annual subscriptions fall due on the first day of the month following approval to the club and annually thereafter, upon membership renewal. Since approval by the Management Committee is normally a formality once an application has been received, payment is requested with the application form. In the unlikely event the Management Committee does not approve the application all monies will be refunded in full.

Sundowners Yacht Club is a private company limited by guarantee, which means that elected members become members of the company, with their liability limited to £1 in the unlikely event of the club being wound up.

### 6. Membership Subscriptions

The annual membership rate for all members is currently £25.00 only if paid by direct debit. Payment by card or bank transfer is £29.50. The direct debit can be setup at the following link, https://pay.gocardless.com/AL0000AWGGN379 this is our preferred method of payment as it reduces our administration time and costs.
